**Rules:** The regatta will be governed by the current Racing Rules of Sailing, the prescriptions of US Sailing and the rules of the USSCA, except as altered by the Sailing Instructions or as posted on the Regatta Bulletin Board.

**Eligibility:** The regatta is open to any registered member of the USSCA. Membership forms will be available at registration.

**Sailing instructions:** SI's will be available at registration. All courses will be listed. Racing will take place on the Cooper River between Cuthbert Boulevard and Route 130.

**Number of Races:** The Race Committee will attempt to sail as many races as possible. One race will constitute a regatta.

**Scoring:** Scoring will be the low-point scoring system,

  - 10:00 Signal for first race of the day with subsequent races to follow and a lunch break
  - 3:00 No races to commence after this time
  - 5:00 Happy hour

- 10:00 Signal for first race of the day with subsequent races to follow.
- No races to start after 13:00
- Lunch and awards to follow the last race of the day

**Registration Fee:** The registration fee will be \$70.00. After June 30<sup>th</sup> a \$5.00 late fee will be added. All competitors will be required to show proof of USSCA membership. The registration fee will cover a participation gift, breakfast, lunch, and dinner on Saturday and breakfast and lunch on Sunday. There will be beer, snacks and soda following the races both days.

**Awards:** Trophies will be awarded to the Top Five, Master's, and Youth.
